FINANCIAL STATEMENT OF SUPPORT

for a registration as a Union citizen or as a national of the other contracting parties of the European Economic Area Agreement (Norway, Iceland and Liechtenstein) and the Swiss Confederation in accordance with articles 4 and 6 of the amended law of 29 August 2008 on the free movement of persons and immigration

Important note:

- This financial statement of support is <u>only valid</u> in the context of a <u>registration of a Union citizen</u> (or a national of the other contracting parties of the European Economic Area Agreement) as a <u>non-working person with proof of sufficient financial means of subsistence</u>. Information on the conditions and steps to be taken in connection with a declaration of a registration is available on the www.guichet.lu website.
- 2. The financial statement of support is a <u>preliminary step</u> to be taken before applying for a registration certificate as a non-working person with proof of sufficient financial means of subsistence. Its acceptance doesn't constitute authorization to enter or reside in Luxembourg and does not prejudge the decision that will be taken on the registration declaration.
- 3. The sponsor has to be a **natural person who has Luxembourgish nationality and resides in the** Grand Duchy of Luxembourg or who is authorized to stay in the Grand Duchy of Luxembourg for a period of at least one year.
- 4. In this context, the financial statement of support is considered to be proof of sufficient resources on the part of the foreign national making the application. By this financial statement of support, the sponsor commits himself towards the foreign national and the Luxembourg State to assume responsibility for the costs of the foreign national's stay, including health costs, and return costs for the duration of the stay as indicated under (20). After this period and for a period of two years, the guarantor is jointly and severally liable with the foreign national towards the State for the reimbursement of the costs of the foreign national's stay, including health costs, and return costs and must reimburse, where applicable, the costs of the stay or repatriation borne by the government of Luxembourg. The sponsor is released from his commitment if he provides proof that the foreign national has left the Schengen area. The sponsor may not withdraw his financial statement of support unless the Minister or his delegate accepts a new financial statement of support has been granted a residence permit on another basis.

Procedure to follow :

- 1. To use a financial statement of support, the sponsor must first go to the municipal administration (« administration communale ») of his place of residence in Luxembourg so that the mayor or his representative legalizes the signature of the sponsor, that is to say it certifies that the sponsor has personally signed this form.
- 2. The duly completed form with all the documents that have to be enclosed (please see below) must be submitted to the General Department of immigration of the Ministry of Home Affairs. (postal address: B.P. 752, L-2017 Luxembourg).
- 3. Upon approval of the financial statement of support, a copy is given to the sponsor with the indication of the approval (the document has to be signed by the Minister or his representative). The foreigner for whom the financial statement of support is made, must use it within six months from the date of approval.

4. The approved financial statement of support must be shown when a declaration of registration as a non-working person with proof of sufficient financial means of subsistence is made to the local authority.
