## INFORMATION NOTE ON DATA PROTECTION

### Declaration of the entity intending to be recognised by the competent authority to provide practical skill training and assessment of remote pilots

Personal data are processed for the purpose of aviation security by guaranteeing that declarations of UAS operator that intended to provide practical skill training and assessment of remote pilots are registered in the national database.

The legal basis for this processing is the Commission Implementing Regulation (EU) 2019/947 on the rules and procedures for the operation of unmanned aircraft.

Failure to provide these data will prevent the declaration and thus the possibility of being recognised by DAC to provide practical skill training and assessment according to a standard scenario.

The data subject has the right :

- to access to their personal data,
- to rectification or erasure of personal data or restriction of processing,
- to object to processing,
