## INFORMATION NOTE ON DATA PROTECTION

### Operational declaration according to a standard scenario (STS)

Personal data are processed for the purpose of aviation security by guaranteeing that operational declarations are registered in the national database.

The legal basis for this processing is the Commission Implementing Regulation (EU) 2019/947 on the rules and procedures for the operation of unmanned aircraft.

Failure to provide these data will prevent the operational declaration and thus the operation of UAS according to a standard scenario.

the data subject has the right :

- to access to their personal data,
- to rectification or erasure of personal data or restriction of processing,
- to object to processing,
