



## APPLICATION FOR EXEMPTION FROM SUBMITTING A FULL COPY OF THE BIRTH CERTIFICATE

This exemption is granted pursuant to Article 7 of the law of 19 December 2020 on the change of surname and first names and amending the amended law of 8 March 2017 on Luxembourg nationality, which provides:

'Art. 7.

(1) The applicant must submit the following documents, together with the application, to the Minister of Justice:

1° a full copy of their birth certificate;

2° a copy of their valid passport or, failing that, a copy of another identity or travel document;

3° where applicable, authorisation from the family court judge to submit an application for a change of the surname and first names;

4° where applicable, any other supporting document.[...]

(4) Upon reasoned request, the Minister of Justice may grant an exemption from producing any of the documents referred to in this article where the applicant demonstrates that it is materially impossible to produce them.

If such an exemption is granted, the applicant may provide any evidence demonstrating that the legal conditions have been fulfilled. [...].'

Please note that a false statement by the author may result in criminal sanctions. Article 220 of the Criminal Code states that:

'False testimony in civil and administrative matters is punishable by imprisonment for a term of two months to three years.'

**The application must be in writing, dated and signed by the author. The applicant must attach a copy of a valid identity card or passport.**
