The scope of the digital power of attorney cannot be changed and provides access to:

- the private eSpace of the principal; and
- their personal data and those of their family members (ascendants, descendants, spouse) recorded in the National Registry of Natural persons (RNPP).

It includes all past, present and future online services eligible for a power of attorney*, carried out by the principal or other agents, including the management of administrative procedures including the pre-filling of personal data as well as the consultation of personal data. It expressly excludes acts of disposition, such as last wills and testaments or transfers of ownership.
