- Please fill out the form on a computer and submit the form by [30 April 2021](#) at the latest.
- We recommend that forms be submitted in person or sent by registered letter with acknowledgement of receipt. We don't send a confirmation of receipt.
- All documents provided must be in Luxembourgish, French, German or English; an official translation will be required for any other language (list of sworn translators on www.mj.public.lu).
- No additional documents will be accepted after the form has been submitted; please wait for an official letter requesting the missing documents in your application.
- Your file or national identification number should be referenced in any communication with the Ministry of Higher Education and Research - CEDIES.

You may in this case, if applicable, submit an application for reassessment of your grant. The application must be submitted in writing together with a certificate issued by the competent administration stating the start date or date of cessation of payment of the allowance concerned.
