#### FINANCIAL STATEMENT OF SUPPORT

for a third-country national in the context of an application for an authorization to stay as a student or an application for renewal of a residence permit as a student

in conformity to article 4 of the modified law of 29 August 2008 on the free movement of persons and immigration

### **Important remarks:**

- This financial statement of support is valid <u>only in the context of an application for a residence</u> <u>permit as a student or an application for renewal of a residence permit as a student for a third <u>country national</u>. Information on the conditions and steps to be taken to obtain such an authorization to stay or a residence permit is available on the website <u>www.guichet.lu</u>.

- 2. The financial statement of support is only a **preliminary step** to be taken in the context of an application for an authorization to stay / residence permit. Its approval is not worth authorization to enter or to stay in Luxembourg and does not prejudge the decision that will be taken on the authorization of stay or the residence permit.
- 3. The sponsor who subscribes to financial statement of support must be <u>a natural person who has</u> the Luxembourg nationality or who is authorized to stay in the Grand Duchy of Luxembourg for <u>a period of at least one year.</u>
- 4. The financial statement of support is considered in this context as proof of sufficient resources of the foreigner who makes the application for an authorization to stay / residence permit. By this financial statement of support, the sponsor undertakes with respect to a foreigner and the Luxembourg State to pay for the expenses of stay, including the expenses of health, and of return to the country of origin for the duration of the stay as indicated under (20). After this period and during two years, he is jointly and severally liable with the foreigner with respect to the State of the reimbursement of living expenses, including health costs, and return to the country of origin and must reimburse, if necessary, the costs of stay or return borne by the Luxembourg State. The sponsor is released from his engagement if he proves that the foreigner has left the Schengen Area. The sponsor may not withdraw from his care obligation unless the Minister or his delegate accepts a new financial statement of support signed by another person or if the person supported has been granted an authorization to stay for another purpose. Please note that an application for international protection lodged by the person supported does not release the sponsor from his or her commitment to cover the costs.

# **Procedure to follow:**

- 1. To use a financial statement of support, the sponsor must first go to the municipal administration (« administration communale ») of his place of residence in Luxembourg so that the mayor or his representative legalizes the signature of the sponsor, that is to say it certifies that the sponsor has personally signed this form.
- 2. The form must then be submitted to the General Department of immigration of the Ministry of Home Affairs. To this end, the sponsor sends the form duly completed and legalized by his

- municipality of residence to the General Department of immigration (postal address: B.P. 752, L-2017 Luxembourg).
- **3.** Upon approval of the financial statement of support, a copy is given to the guarantor with the indication of the favorable opinion. The foreigner for whom the commitment is made must use it within six months from the date of approval.
- **4.** The approved financial statement of support must be enclosed to an application for an authorization to stay as a student or an application for renewal of a residence permit as a student.

- a complete copy (all pages) of the valid passport of the person supported.
