

Application form for a transport authorisation for radioactive materials in Luxembourg

By the present form, the undersigned applies for a transport authorisation for radioactive materials falling under the authorisation regime defined by the radiation protection law of 28 May 2019 and the radiation protection regulation of 1 August 2019. The transport of nuclear fuel and uranium hexafluoride is forbidden (law Art. 35.).

The application for a transport authorisation by air shall be accompanied by the special or general transport authorisation delivered by the Minister of Transport or his delegate.

The undersigned hereby acknowledge that by 1 June of every year, carriers with an authorisation for the transport of radioactive materials, excluding authorisations limited to the transport of packages bearing the identification number UN 2908, 2909, 2910 and 2911, are required to pay a tax of EUR 500.
