Terminology

The person who is **entrusting** another person with the authority to carry out procedures in their name is called '**principal**'.



The person who is **given** the authority to carry out procedures in the name of another person is called '**agent**'.

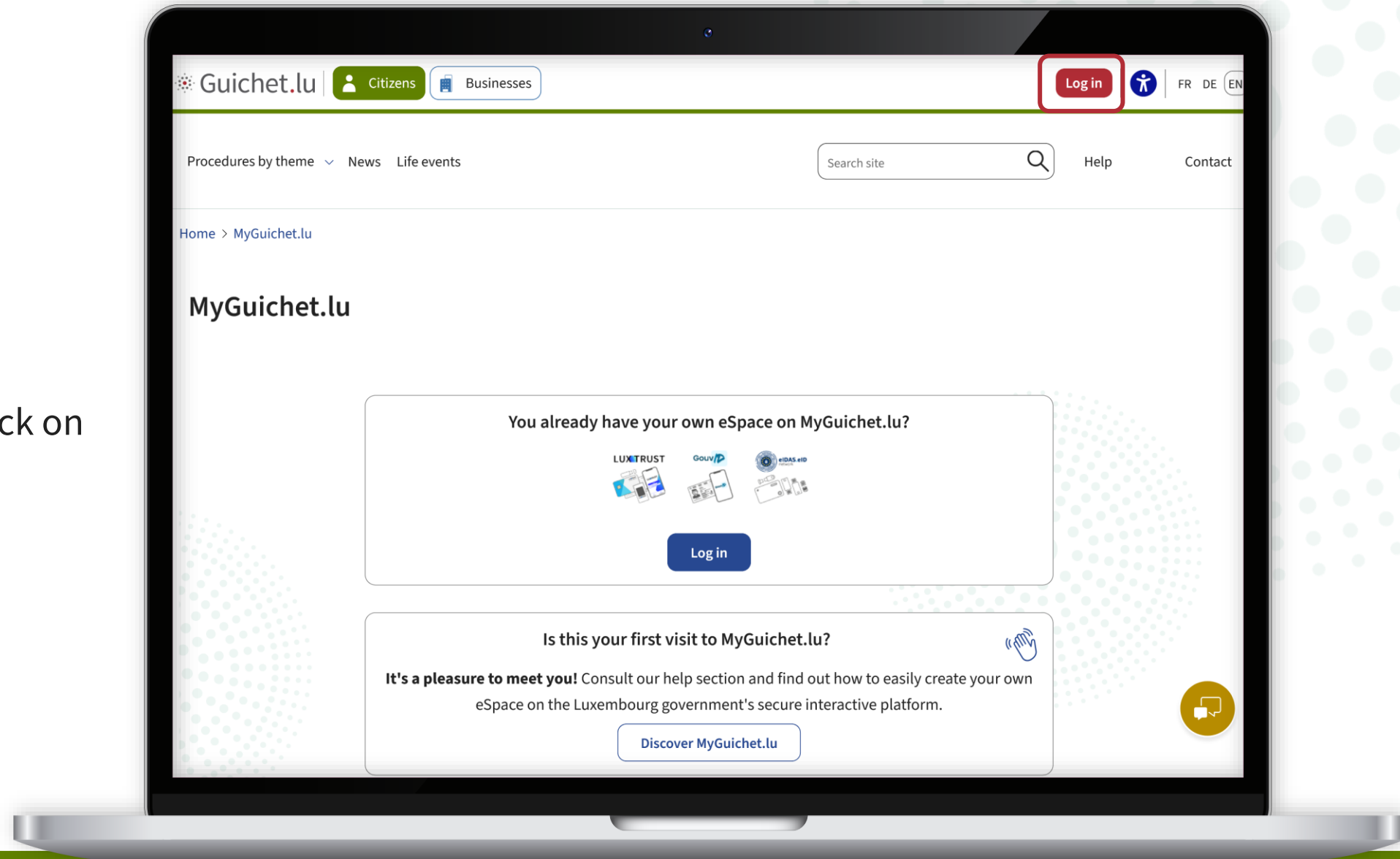


In this tutorial, we will explain to you how you, **in your capacity as agent**, can create a digital power of attorney online via your private eSpace on MyGuichet.lu.

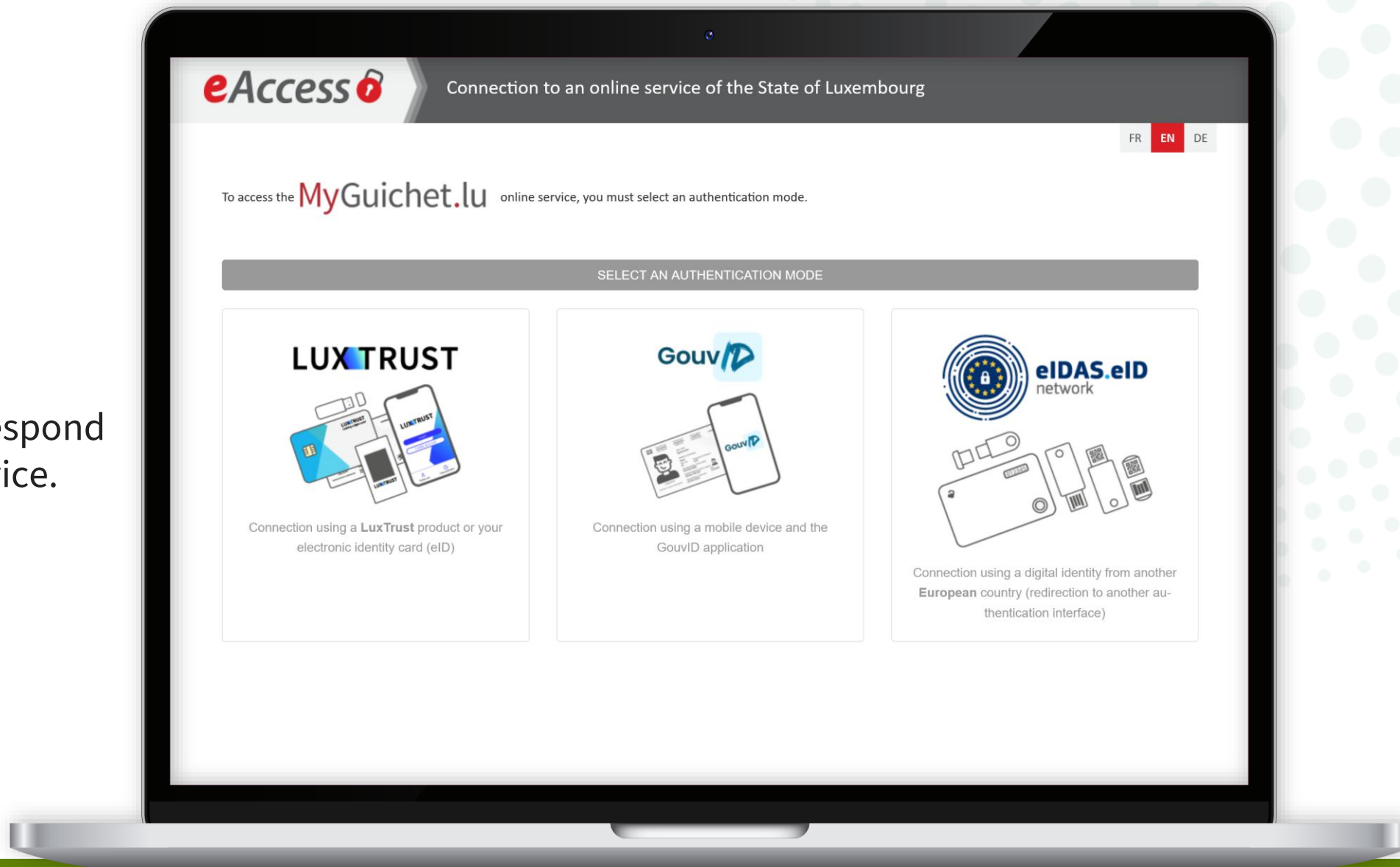

Before starting

What is a digital power of attorney?

A digital power of attorney is a type of power of attorney that allows a natural person to access another natural person's private eSpace via their own MyGuichet.lu account. A digital mandate can be created either by the principal (i.e. the person who grants access) or by the agent (i.e. the person who receives access).

Who is concerned

To create a digital power of attorney online via MyGuichet.lu, both parties must:

- have a private eSpace;
- be of legal age (18 years or older);
- not be placed under guardianship or curatorship.

Please note, digital powers of attorney for **persons placed under guardianship by a Luxembourg court** can only be created in person at the Guichet.lu reception desk (located at 11 Rue Notre-Dame in Luxembourg City). More information is available at guichet.lu/mandat-numerique.

Information required for the creation

Whether you are creating the digital power of attorney as the principal or agent, you will always need the following information about the other party:

- their 13-digit Luxembourg national identification number (*Matricule*); **and**
- [their private eSpace identifier](#) (also called 'ID').

Processing time

It takes about 5 minutes to create a digital power of attorney via MyGuichet.lu.

Scope of the power of attorney

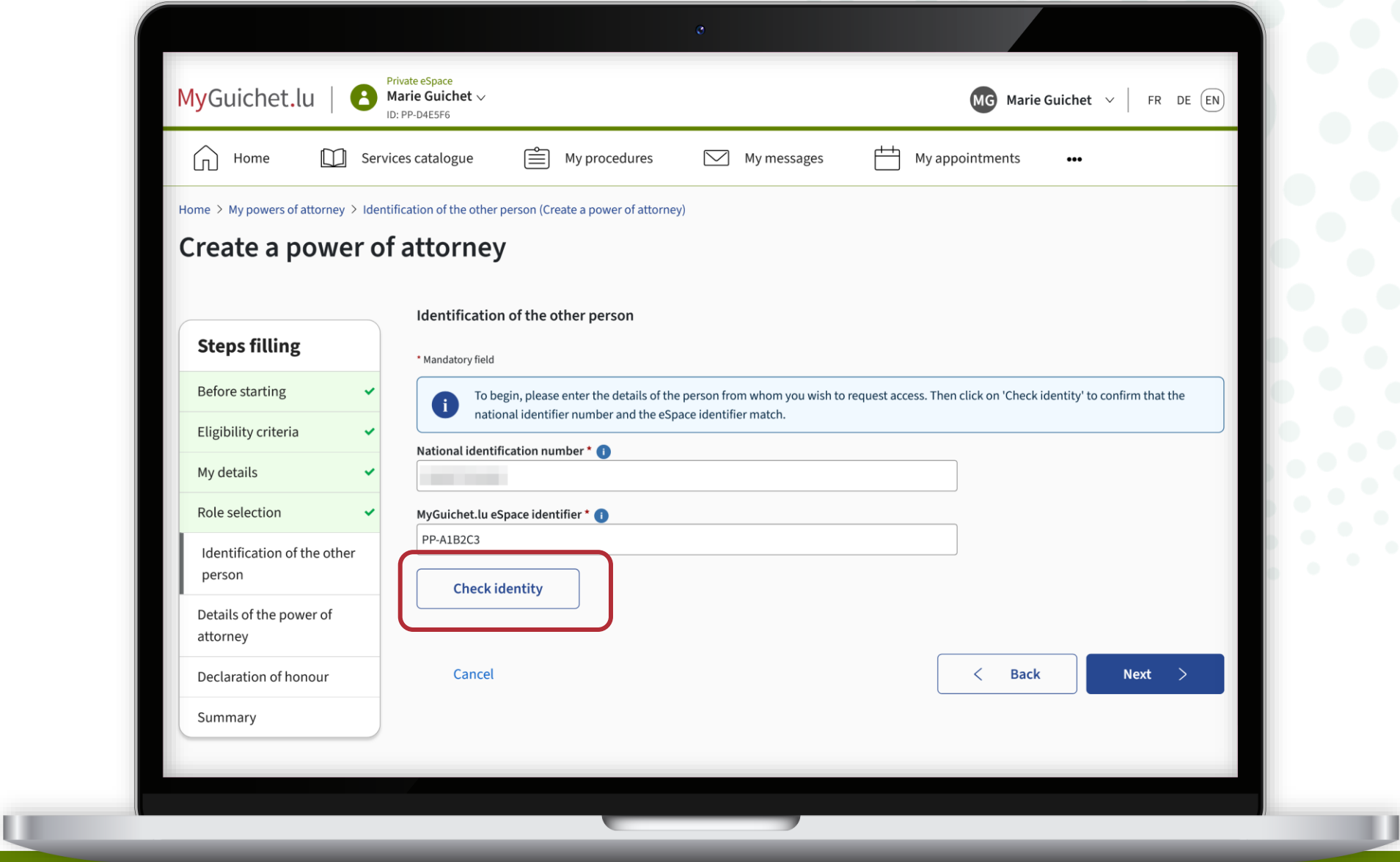

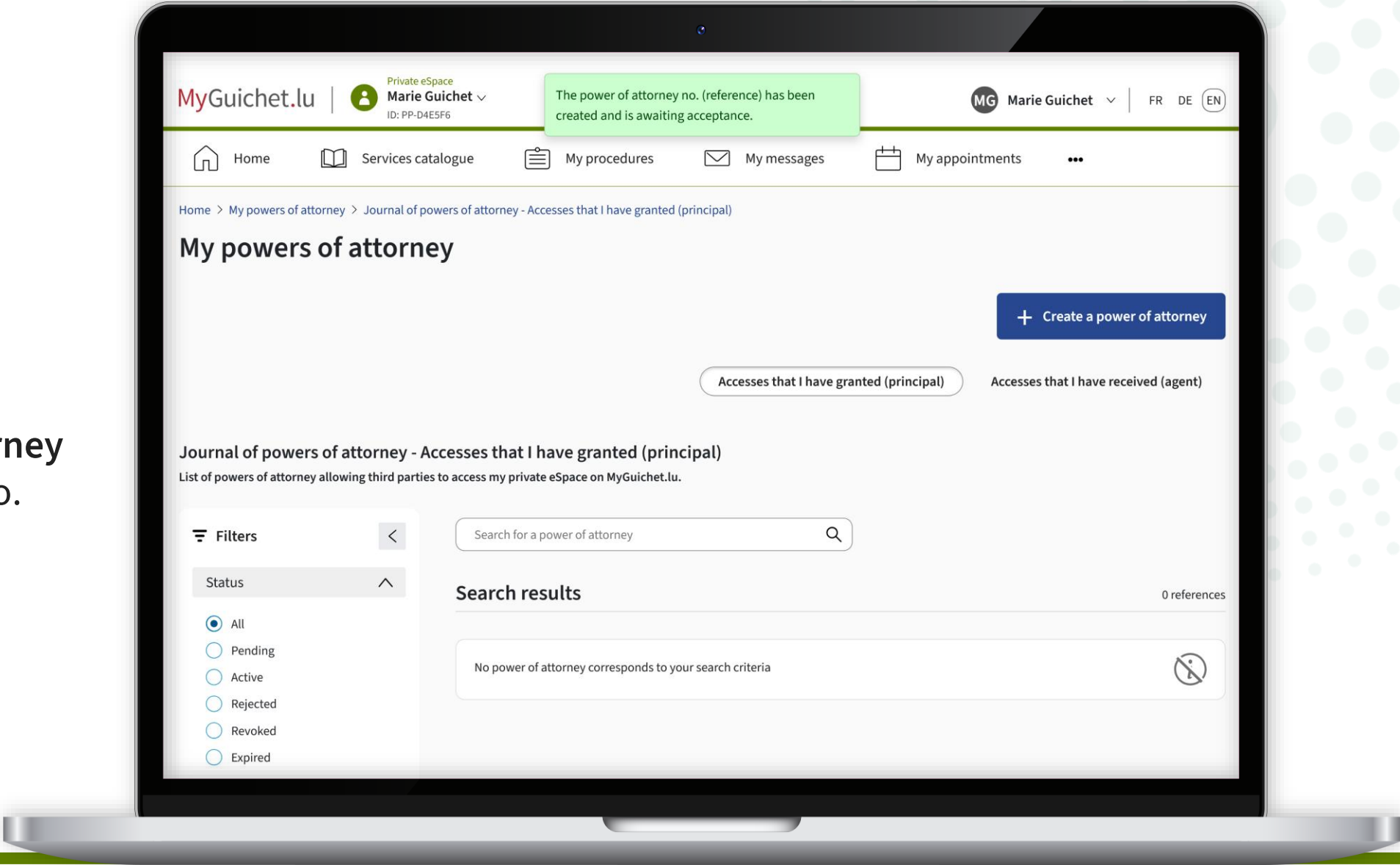
